Olivewood Religious Articles - Permitted Vendors - 2<sup>nd</sup> Update

## **POLICY & BACKGROUND:**

During the year, you may be contacted by representatives of the vendors included below, requesting an invitation to come to your parish. As you know, the purpose of these organizations is to inform people about the situation of the Christians in the Holy Land and to market olivewood handcrafted religious articles, the sale of which provides steady employment for and support to Christian families in the Jerusalem area.

## PLEASE NOTE:

- **1.** While Bishop Parkes has permitted certain vendors to approach pastors in order to market their articles, <u>in no way does he endorse any vendor</u> for solicitation in our parishes.
- **2.** After Bishop Parkes grants permission following the vendor's request, a letter from the Chancellor's Office is sent to the vendor, informing him/her of this permission. This permission is good for one year and renewal must be requested by the vendor.
- **3.** While permitted vendors are allowed to approach individual pastors, the decision to invite a vendor to a parish is always left to the discretion of the pastor, and we ask that the vendor respectfully accept that decision.
